WHEREAS, the City Council of the City of Troy, Alabama, has duly assembled at a regular meeting with the Mayor and Council members present; and


WHEREAS, the City Council has considered the City of Troy's participation in the FY2023 Safe Streets and Roads for All (SS4A) Grant Program; and

WHEREAS, the City Council has determined that the City of Troy, Alabama shall participate in the FY2023 Safe Streets and Roads for All (SS4A) Grant Program;


NOW THEREFORE, BE IT RESOLVED by the City of Troy City Council as follows:

1. That the Mayor of Troy is hereby authorized and directed to sign any and all documents that are necessary for the City of Troy to participate in the FY2023 Safe Streets and Roads for All (SS4A) Grant Program.
2. That the Mayor of Troy, Council Members, City Clerk, or other designee are authorized and directed to maintain and provide any information necessary in the completion and any and all forms necessary for the City to participate in the program.
3. That the Mayor, Council Members, City Clerk, or other designee are further directed to provide any information to the Committee in determining whether or not the City shall receive funding from this Program.
4. That, if funded, the City of Troy is authorized to enter into a funding agreement the appropriate authority, for the purpose of this funding, once such agreement has been reviewed and approved by the City Attorney.
5. That, if funded, the City of Troy is authorized to enter into such agreements required for the design and the construction engineering and inspections for the FY2023 Safe Streets and Roads for All (SS4A) Grant Program project, once such contracts and/or agreements have been reviewed and approved by the City Attorney.
6. That the agreements be executed in the name of the City of Troy for and on behalf of the City of Troy by its Mayor.


