Audit Findings

Audit Narrative

The City of Troy Police Department had its PREA Audit conducted on September 16, 2019. The facility did well in preparing files for audit and assisting the Auditing Team in setting up interviews with staff, administration, and an inmate, (during the time of audit no detainees were present) that were detained at the time of Audit. The files were neat but work still had to be done in efforts to easily decipher the Jail component from detention. The facility worked very hard during and after the Audit to ensure that standards were satisfactorily met.

Troy Police department are working on ways, which were suggested to better educate both their residents/inmates and staff to ensure the intent of PREA is clearly understood. The inmates that was interviewed at the time of audit was knowledgeable of the standards and understood the purpose of PREA, knew how to properly report and felt very confident in the safety of the facility.

Attempts were made to contact Medical Staff by phone after the audit although the facility still coordinates with local hospital authorities and crisis centers. The Investigator role hasn't changed since the previous audit and is still housed within the agency.

Upon review of the files and through interviews, it was reiterated that PREA Audits are like none other, the Auditor has to be satisfied that policy or procedure exist to satisfy the standard, that the practice in place is consistent with the standard and policy, and that the policy and practice has become institutionalized.

Facility Characteristics

- 2. Enforce laws and ordinances in a fair and impartial manner and recognize the constitutional rights of all persons.
- Contribute to the safety and security of the community by apprehending those who commit criminal acts and by developing partnerships to prevent, reduce or eliminate community problems.
- 4. Provide continuous services on a professional level.

It is suggested that he consider a PREA Compliance Manager due to patrolling at the time of Audit there were two other staff assisting at the time of audit that allowed for sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards in the facility.

During an interview with the PREA Coordinator, a great effort was shown to implement the PREA standards and the intent thereof.
